Course Title: Fire Arson Investigation (ARIN)

Course Code: ARIN

Length of Course: 16 Hours **Lecture/Lab Breakdown**: 14/2

<u>Prerequisites:</u> *ADFR* and at least 5 years member of a Fire Department as a Chief, Line Officer, or member of an investigation team assigned to determine cause and origin. Students must have prerequisite regarding investigative duties and bring written evidence of same to first day of class.

Referenced Texts: NFA Fire/Arson Detection

<u>Course Goal:</u> to train those members whose responsibility is to determine the Origin & Cause of a given fire.

<u>Description of Course</u>: This course introduces the student to a step by step procedure in determining the Origin & Cause of a given fire and the awareness of possible incendiaries. Includes both building & vehicle fires starting with the motives of those individuals who are fire setters. It is designed for first responders who wish additional knowledge in fire cause and origin determination.

<u>Description of Methodology to be used:</u> Classroom instruction with the use of video, slides, props, on-site scenes if available.

Student Equipment/Supply Needs: NFA Manual, Notebook, Pen/Pencil; Coveralls, hard hat, boots, and eye protection should be available.

Equipment/Audiovisual/Supply requirements: Classroom w/ usual amenities; AV equipment to support instructor's audiovisual package; A burn building or acquired structure and motor vehicle where fire "sets" can be made, extinguished, then investigated is highly desirable.

- 4. demonstrate the proper procedure for fatal fire investigations in the Commonwealth of Pennsylvania.
