<u>Length of Course:</u> 16 Hours <u>**Lecture/Lab Breakdown:**</u> 14/2

Prerequisites: FIPO

<u>Course Goal:</u> To set forth the specifics of Pennsylvania law and it's operation within the scope of the authority of special fire police and to correct certain misconceptions related thereto.

Description of Course: This course is an in-depth study of the laws with which fire police, fire departments and the municipality are jointly involved. This includes powers, negligence, liability, detention, training, Crimes Code, Vehicle Laws and their application.

<u>Competency Evaluation Mechanism (Brief description-attach copy):</u> Law search (by student) to fit a specific situation. Review/Test - student corrected.

Course Objectives (specific):

- 1. To show how the law concerning fire police evolved and how their police power increased.
- 2. To correct misconceptions concerning the legal operations of fire police.
- 3. To explain specific points of the Fire Police Law, The Bill of Rights and the Civil Rights Act (USC 42, Sec. 1983).
- 4. To show by examining PA Law, the extent of the scope of authority of fire police.
- 5. To encourage fire police to be extremely cautious in using their "necessary" authority (police power).
- 6. To show the extent of liability and some defenses that help to avoid it.
- 7. To show fire police how to conduct themselves in a court of law.
- 8. To examine and show application of some specific Pennsylvania laws.
