Course Title: Community and Worker Right to Know (RTKN)

<u>Length of Course:</u> 4 Hours <u>Lecture/Lab Breakdown:</u> 3/1

Prerequisites: None

Referenced Texts: Pennsylvania Department of Labor and Industry "Pennsylvania Worker and Community Right to Know Program - Training Tools for Non-Manufacturing Employees"

<u>Course Goal:</u> Upon completion of this course, the student will have received an overview of his/her rights and responsibilities under the Pennsylvania Worker and Community Right to Know Act.

Description of Course: This course is designed to meet the annual training requirement of Section 8 of the Pennsylvania Worker and Community Right to Know Act. It provides an overview of the Act as it applies to public sector employees, emphasizing the use and importance of labelling and reading of Material Safety Data Sheets (MSDS).

<u>Description of Methodology to be used: (Brief)</u> Lecture; depending on the background of the students, some use of guided discussion may be appropriate.

Student Equipment/Supply Needs: Notebook, pen/pencil

<u>Equipment/Audiovisual/Supply requirements:</u> Chalkboard/flip chart; sample copy of MSDS (one per student). Referenced text contains numerous illustrations convertible to slide or overhead format; audiovisual equipment will depend on which format is chosen. Samples of labels, additional hand-out material, etc., may be provided at the instructor's/educational training agency's discretion.
